

## Coordinated Family Support New Vendor Orientation (CFSNV)

October 15, 2024 from 9:00 AM to 12:00 PM

Registration is now open for the October 15, 2024 Coordinated Family Support New Vendor Orientation (CFSNV). The CFSNV will be conducted virtually via Zoom. Successful completion of the CFSNV is one of the requirements for vendorization as a Coordinated Family Support provider.

To register for the CFSNV, please complete each of the following items by no later than 11:59 p.m. on Tuesday, October 1, 2024:

1. Register for the CFSNV using the link found at the bottom of this post.
2. Send an email to [resource@sarc.org](mailto:resource@sarc.org) that contains the following attachments in support of your request for admission to the CFSNV:
  - A Letter of Intent that explains:
    - (1) why you are interested in providing Coordinated Family Support services to SARC-sponsored individuals,
    - (2) your background and experience working with I/DD individuals, and
    - (3) how you will implement the HCBS Final Rule in providing services to SARC-sponsored individuals.
  - An updated copy of your professional resume.
  - A request for language interpretation for the orientation, specifying the language needed (if applicable).

Each of the described documents must be sent as a separate Word or pdf attachment to your email. Letters of Intent or resumes included as in-line text in your email will not be accepted.

Please make sure that your Letter of Intent and resume is free of typographical errors before submission. You must register for the CFSNV through the link below AND submit all supporting documents described above by no later than 11:59 p.m. on October 1, 2024 in order to be considered for admission. Registrations and supporting documents timestamped after 11:59 p.m. on October 1, 2024 will not be considered for admission.

You will receive an email by October 8, 2024 that either confirms or denies your admission to the October 15<sup>th</sup> CFSNV. If you are admitted, you will receive a Zoom link from Resource Specialist Kai Reade. Please note that no more than two (2) individuals from a single agency will be admitted to the CFSNV unless prior approval is obtained from Community Resources Unit Manager Ann Sieber.

We do not maintain a waitlist for admission. If you are not admitted to or are unable to attend the October 15<sup>th</sup> CFSNV, you will need to re-apply for admission to the next CFS orientation scheduled for January 2025.
