(3) how you will implement the HCBS Final Rule in providing services to SARC-sponsored individuals.

- An updated copy of your professional resume.
- A request for language interpretation for the orientation, specifying the language needed (if applicable).

Each of the described documents must be sent as a separate Word or pdf attachment to your email. Letters of Intent or resumes included as in-line text in your email will not be accepted.

Please make sure that your Letter of Intent and resume is free of typographical errors before submission. You must register for the SLSNV through the link below AND submit all supporting documents described above by no later than 11:59 p.m. on October 24, 2024 in order to be considered for admission. Registrations and supporting documents timestamped after 11:59 p.m. on October 24, 2024 will not be considered for admission.

You will receive an email by October 31, 2024 that either confirms or denies your admission to the November 7<sup>th</sup> SLSNV. If you are admitted, you will receive confirmation and registration instructions from Resource Specialist Kai Reade. Please note that no more than two (2) individuals from a single agency will be admitted to the SLSNV unless prior approval is obtained from Community Resources Unit Manager Ann Sieber.

We do not maintain a waitlist for admission. If you are not admitted to or are unable to attend the November 7<sup>th</sup> SLSNV, you will need to re-apply for admission to the next SLS orientation scheduled for February 2025.
